Tangerine: An anaphylactic reaction to tangerine has been reported and confirmed by patch testing (Ebo et al. 2007). Contact dermatitis due to tangerine essential oil in a perfume has also been reported and confirmed by patch testing (Vilaplana 2002). Long-term use of tangerine peel is not recommended (Chen and Chen 2004). LD50 in mice of the compound tangeretin is 780 mg/kg and the compound hesperidin is 850 mg/kg.
